On May 20, over 200 received their Juris doctorate degree during Southern University Law Center’s Spring 2022 Commencement Ceremony. The ceremony was held at the F. G. Clark Activity Center on the campus of Southern University Baton Rouge. Honorable Dana M. Douglas, United States Circuit Court Judge of the United States Court of Appeals for the Fifth Circuit, served as the commencement speaker. Chancellor John Pierre opened the ceremony with a

warm welcome to guest, family, and friends. He expressed how proud he is of this group of students because they succeeded despite beginning law school at the height of a nationwide pandemic. Pierre gave the new Law Center alumni words of encouragement and well wishes.

Douglas spoke about being resilient and pivoting through disaster. Douglas reflected on her career trajectory and went on to describe how her career froze during the inevitable tragedies of 9/11, Hurricane Katrina, and Covid-19.

Prior to taking the bench, Douglas practiced in the areas of energy, product liability, and intellectual property litigation in the state and federal courts of Louisiana. She currently sits on the boards of the Thomas More American Inns of Court and Federal Bar Association. Douglas is a past president of both the New Orleans Bar Association and the Greater New Orleans Louis A. Martinet Society. In addition, she is also a charter and founding member of the Louisiana Chapter of the Women's Energy Network.

Douglas poured positive affirmations into the graduates. She reminded them that they are capable of anything. She ended her profound address by saying, "You are indeed ready for it all. Better people. Better lawyers."

SULC HOSTS INAUGURAL COLLEGIATE GAMING TOURNAMENT CALLED THE BLUFF OPEN



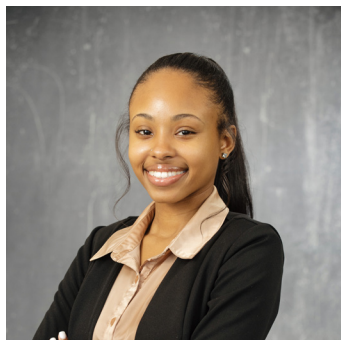
The Southern University Law Center hosted The Bluff Open Tournament featuring Fortnite at the newly launched Esports Innovation Lab located on the campus of Southern University.

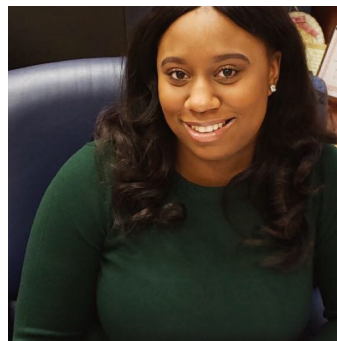
